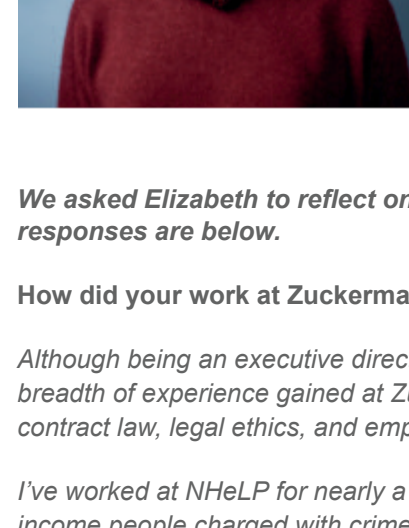

## Alumni Highlights

### Alumna Spotlight: Elizabeth G. Taylor

**Firm Background:** Partner, 1996-2011



Throughout her career, **Elizabeth Taylor** has used her legal training in a variety of different roles, all aimed in some way at trying to do some good. She started her career at the DC Public Defender Service and is now back in the nonprofit world, serving as the Executive Director of the **National Health Law Program (NHeLP)**, a nationally recognized legal nonprofit dedicated to protecting and advancing the health rights of low-income and underserved individuals.

Prior to NHeLP, Elizabeth spent fifteen years as a partner at Zuckerman Spaeder, where she litigated civil and criminal cases in federal and state courts across the country. After leaving the firm, she moved to the U.S. Department of Justice, where she served as Principal Deputy Associate Attorney General during the Obama Administration and helped develop federal policy and litigation strategy regarding several federal health care initiatives, including the Affordable Care Act and emergency contraceptives.

**We asked Elizabeth to reflect on her career, including her time at Zuckerman Spaeder. Her responses are below.**

#### How did your work at Zuckerman Spaeder prepare you for your current role?

*Although being an executive director doesn't require legal training, it helps. I am able to draw on the breadth of experience gained at Zuckerman Spaeder, from leading teams to knowing enough about contract law, legal ethics, and employment law to spot challenges and call for expert help when it is needed.*

*I've worked at NHeLP for nearly a decade, and it feels like a wonderful arc to a career. Fighting for low-income people charged with crimes is crucial to the fairness of our justice system. Getting resources to families and children so that they don't find themselves in the criminal justice system is crucial to our country's future. Many friends from Zuckerman Spaeder support NHeLP through service on the board, pro bono assistance, and financial support. All are greatly valued.*

#### What drew you to join Zuckerman Spaeder?

*I came to the firm initially because of the flexible work schedule that allowed me to work and raise three boys. I stayed because the work was challenging, and the Zuckerman Spaeder lawyers and staff became great friends.*

#### What is your most memorable moment and the biggest takeaway from your time at Zuckerman Spaeder?

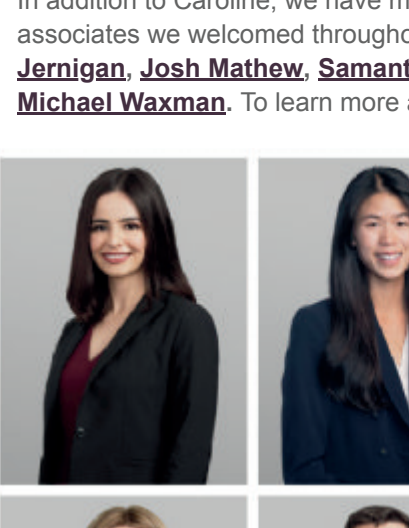

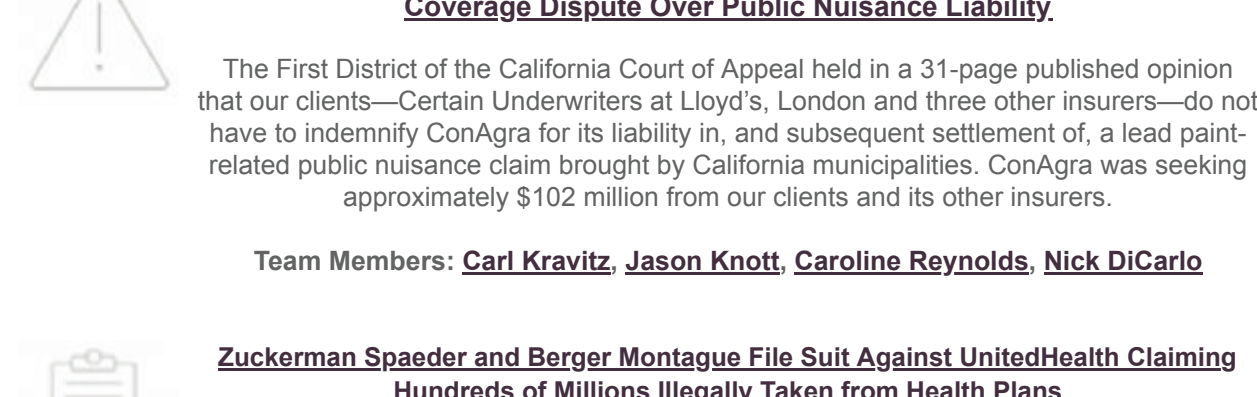

### Recent Case Highlights



#### [Win Restores Federal Drug Discount Program Savings](#)

On behalf of the American Hospital Association, the American Association of Medical Colleges, America's Essential Hospital, and member hospitals, we achieved a significant win in its fight against the Department of Health and Human Services' policy of reducing Medicare payments for drugs acquired under the 340B drug discount program, which provides important benefits for certain nonprofit hospitals and community health centers and other federally funded clinics that serve vulnerable communities. On September 28, Justice Rudolph Contreras of the U.S. District Court for the District of Columbia granted our motion to vacate HHS's 340B payment policy for the remainder of 2022.

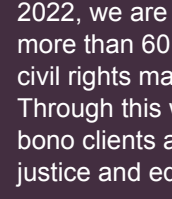

#### [California Courts Rule in Favor of Our Clients in \\$102 Million Insurance Coverage Dispute Over Public Nuisance Liability](#)

The First District of the California Court of Appeal held in a 31-page published opinion that our clients—Certain Underwriters at Lloyd's, London and three other insurers—do not have to indemnify ConAgra for its liability in, and subsequent settlement of, a lead paint-related public nuisance claim brought by California municipalities. ConAgra was seeking approximately \$102 million from our clients and its other insurers.

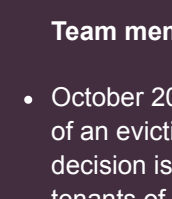

#### [Zuckerman Spaeder and Berger Montague File Suit Against UnitedHealth Claiming Hundreds of Millions Illegally Taken from Health Plans](#)

In a class action lawsuit filed by Zuckerman Spaeder and Berger Montague, plaintiff Rebecca Smith alleges that the administrator of her health insurance plan, UnitedHealth Group, has illegally taken hundreds of millions annually from employer-sponsored, self-funded health plans like the one that covers Ms. Smith. More recently, she alleges that in recent years United has doubled-down on a practice called "cross-plan offsetting," in which United uses self-funded plan benefit payments that are owed to that plan's members and, instead of paying them, redirects those funds into its own pocket to recover an alleged overpayment it caused one of its fully insured plans to make to the same provider.

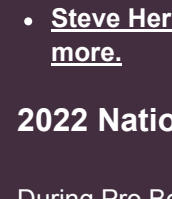

#### [Court Grants Final Approval of "Historic" \\$2.67 Billion Settlement](#)

In a case where our attorneys played a lead role, an Alabama federal court has granted final approval to a Blue Cross Blue Shield (BCBS) settlement that will pay \$2.67 billion to plaintiffs – the largest settlement in history for a private antitrust case with no government involvement – and bring sweeping changes to the way Blue Cross entities compete in the national health insurance market.

**Cy Smith** was court-appointed to serve on the five-person Plaintiffs' Steering Committee and **Carl Kravitz** served as co-chair of the Experts' Committee.



#### [Zuckerman Spaeder Wins \\$9 Million for Insurers After Trial on Subrogation Claims](#)

We prevailed at trial for our clients, Certain Underwriters at Lloyd's, London, and other insurers, in a subrogation dispute over millions of dollars in lead paint-related defense costs. In an opinion dated May 3, 2022, the Commercial Division of the New York Supreme Court held that our clients were entitled to recover \$8.076 million, plus additional prejudgment interest, in subrogation from PPG Architectural Finishes, a third-party contractual indemnitor of their insured. On June 27, 2022, the court entered judgment for the insurers for \$9.116 million. That judgment has been satisfied, and the case is concluded.

### Recent Case Highlights

- September 2022 – The plaintiffs in a long-running housing discrimination case are seeking to overturn a district court ruling that would allow the Waples Mobile Home Park in Fairfax, Virginia, to evict tenants based on a family member's immigration status. The appeal, which is being led by the [Legal Aid Justice Center](#) and pro bono counsel Zuckerman Spaeder, has gained support from the DOJ and numerous fair housing and civil rights organizations, all of which have filed amicus briefs stating that the district court ruling, if upheld, would have dramatic consequences for both landlords and immigrants nationwide. - October 2022 – A Baltimore City ordinance that deems abandoned all personal property left at the time of an eviction, violated tenants' constitutional right to due process, according to a district court ruling. The decision is the result of a pro bono lawsuit brought by Zuckerman Spaeder on behalf of two former tenants of a Baltimore rental home. [Read more.](#)
